 Identify the Import Letter of Credit that you wish to amend and move your mouse to the Actions column (far right), which will provide options available to you, being Amend, Correspondence, Cancel or Details. Select the Amend option to proceed.



4. The current Import Letter of Credit terms and conditions are provided under the relative Sections located on the left-hand side of the screen. Review and make any amendments as needed within any of the 9 Sections (General Details, Applicant and Beneficiary Details, Bank Details, Amount and Charge Details, Payment Details, Shipment Details, Narrative Details, Instructions to Bank, and Attachments). Select Next to navigate through each section.



5. The **Preview** screen allows you to review all the inputs. Once the inputs have been reviewed, select **Submit**.
