# Electronic communications from us to you:

- 1. We will send information relating to your trade and working capital facilities and products to your nominated email address for receiving electronic communications from us.
- 2. Your nominated email address must be a valid and unique email address acceptable to NAB.
- 3. Any electronic communications we send to your nominated email address may be signed by NAB by applying an electronic signature.
- 4. All electronic communications to your nominated email address will be deemed to be delivered in accordance with the notice provisions of the facility agreement under which NAB makes your trade and working capital facilities available to you from time to time or as detailed in the Business Lending General Terms available at **Business Lending General Terms** (nab.com.au).
- 5. You must retain a record of each electronic communication we send to your nominated email address as your original counterpart on paper or in another format which is capable of being readily reproduced.

Your nominated email address(es) for receiving electronic communications from us is:

It will be your responsibility to check your nominated email address regularly for electronic communications from us. You may request a copy of information we send you as electronic communication within 7 years after date the information is given.

### Electronic communications from you to us

- 1. You may only send electronic communications to us from your approved sender email address.
- 2. Your approved sender email address must be a unique and valid email address of the officer or representative authorised to send electronic communications to us on behalf of your company.
- 3. All electronic communications from your approved sender email address must include the name and title of the sender, your company name and address, and the email address and telephone number of the sender.
- 4. All electronic communications from your approved sender email address must include a statement of the purpose for which the electronic communication is being sent.
- 5. All electronic communications from your approved sender email address will be deemed to be delivered in accordance with the notice provisions of the facility agreement under which NAB makes your trade and working capital facilities available to you from time to time or as detailed in the Business Lending General Terms available at **Business Lending General Terms (nab.com.au**).
