GETTING STARTED

If you wish to participate online, ensure your browser is compatible.

You will need the latest versions of Chrome, Safari, Edge or Firefox.

You can easily check your current browser by going to: www.whatismybrowser.com

Step 1

Unless you are accessing the online AGM portal directly from the link we provided to you in a personalised shareholder email, to attend, vote and ask questions in real time go to https://web.lumiagm.com.

To log in, you must have the following information:

Overseas residents

> Username

Three-character country code



To proceed into the Meeting, you will need to read and accept the Terms & Conditions.




Step 4

Register as a:

Shareholder


- > Select 'Shareholder or Proxy'
- > Enter your Securityholder **Reference Number** (SRN) or Holder **Identification Number** (HIN) and Postcode or **Country Code.**



Proxyholder


You will need your username and password as provided by Computershare.

- > Select 'Shareholder or Proxy'
- > In the 'SRN or HIN' field enter your username and in the 'Postcode or Country Code' field enter your password.



Guest

- > Select 'Guest'
- > Enter your name and email address.



Step 5

Home page


Once logged in, you will see the **Home** page **1**, which displays the Meeting title and name of the registered shareholder or nominated proxy.

Step 6

View the webcast

If you are accessing the meeting via a computer, the webcast will appear on the right hand side of the screen. Those participating via a tablet or mobile phone, will need to tap the broadcast arrow to view the webcast. Tapping the arrow again will minimise the webcast. You will, however, still be able to hear the audio of the meeting.


Please ensure that you press play on the webcast and that your device is not muted.

To ask a written question

To ask a question select the messaging icon =; type your question in the chat box at the top of the screen and select the send icon ▶. You will receive confirmation that your question has been received.



Step 8

To ask an audio question

To ask a question orally first pause the webcast and select the Asking a Live Audio • -Question link on the Home page no




Step 9

How to vote

When the Chair declares the poll open:

- > A voting icon III will appear on screen and the meeting resolutions will be displayed.
- > To vote, select one of the voting options. •--Your response will be highlighted.
- > To change your vote, simply press a different option to override it.

The number of items you have voted on, or • are yet to vote on, is displayed at the top of the screen. Votes may be changed up to the time the Chair closes the poll.
