Terms and Conditions

Promoter	National Australia Bank Limited (ABN 12 004 044 937), 395 Bourke Street, Melbourne, Victoria, 3000 (NAB).
Competition Period	12.01am (AEST) on 10/08/2026 to 11.59pm (AEDT) on 30/10/2026.
Who can enter?	Only Australian residents who: (a) are aged 18 or over; and (b) download the NAB App and are enrolled into the NAB Goodies "My Offers" section within the NAB app. Enrolment in NAB Goodies program (and, consequently, participation in this competition) is subject to the terms and conditions which apply to NAB Goodies available at nab.com.au/personal/goodies/terms-conditions, as amended from time to time.
Who can't enter?	Employees, directors, officers, management and contractors of the agencies, companies or participating premises directly involved in the planning, execution or conduct of this competition. For the avoidance of doubt, NAB employees (and their immediate families) are eligible to enter, except or any employees directly involved in the planning, execution or conduct of this competition.
Where will the competition run?	The competition will run on the NAB mobile banking app (NAB App), available from the Apple App Store or Google Play Store. Installation and use of the NAB App is subject to the terms and conditions of the NAB App, available at www.nab.com.au/important-information/personal/internet-banking-terms-conditions and the relevant Apple App Store and Google Play Store terms, and which may change from time to time.
Entry instructions	To enter, you must, during the Competition Period: (a) if you have not already, download the NAB App and locate the NAB Goodies "My Offers" section of the NAB App (eligibility for enrolment in NAB Goodies "My Offers" is subject to the applicable terms and conditions at www.nab.com.au/personal/goodies/terms-conditions); and (b) tap 'Activate' on the 'Activate for the chance to win a 2026 AFLW Captains Day signed Sherrin' tile within NAB Goodies in the NAB App, to automatically receive 1 entry into the draw. The Promoter is not responsible if your mobile device is not sufficiently capable for the purpose of submitting an entry.
How many winners will there be and how will they be chosen?	There will be 12 winners determined in respect of this competition. There will be 1 draw conducted. The draw will be conducted at 2pm (AEDT) on 02/11/2026 at Gadens Lawyers, Level 13, 447 Collins Street, Melbourne VIC 3000. The first 12 valid entries drawn randomly from the entries received during the Competition Period will each win a prize. The Promoter may draw additional reserve entries in a draw and record them in order, in case a winning entry/entrant is deemed invalid or a prize is unclaimed (Reserve Entrants).
What can I win?	There will be 12 prizes determined in respect of this competition. Each prize is a Sherrin football signed by one player from each AFLW Club who attended the 2026 AFLW Captains Day valued at \$750 and includes a certificate of authenticity.

	For clarity, where a Club has multiple co-captains and only one co-captain attended, or where a player other than a Club captain attended the AFLW Captains Day, that player will have signed the football. Prize will be sent to the winner's postal address associated with their NAB account and NAB Goodies enrolment, unless an alternative address is provided by the winner. The Promoter is not responsible if the prize is not delivered, or any damage occurs during transit. There is a limit of one prize per person per draw.
Total prize pool	The total prize pool is valued at \$9,000.
How many times can I enter?	You can only enter once during the Competition Period.

Entry

Once the 'Activation' button is clicked in the NAB app and changes to 'Activated', your entry is confirmed. The Promoter is not liable for any problems with communications networks outside its reasonable control. You are responsible for your own costs associated with entering.
