Terms and Conditions

Promoter	National Australia Bank Limited (ABN 12 004 044 937), Level 28, 395 Bourke Street, Melbourne, VIC 3000.
Competition Period	12.01am (AEST) on 23/07/2026 to 11.59pm (AEST) 02/08/2026.
Who can enter?	Only Australian residents who: (a) are aged 18 or over; and (b) download the NAB App and are enrolled into the NAB Goodies “My Offers” section within the NAB App. Enrolment in the NAB Goodies program (and, consequently, participation in this competition) is subject to the terms and conditions which apply to NAB Goodies available at nab.com.au/personal/goodies/terms-conditions, as amended from time to time.
Who can't enter?	Employees, directors, officers, management and contractors of the agencies, companies or participating premises directly involved in the planning, execution or conduct of this competition. Employees (and their immediate families) of the Promoter that are classified as Group 5 employees (Senior Managers and above), are not eligible to enter the competition, regardless of whether these employees are directly associated with the conduct of the competition. How many winners will there be and how will they be chosen?	There will be 3 winners determined in respect of this competition. There will be 1 draw conducted. Entry

Once the 'Activation' button is clicked in the NAB app and changes to 'Activated', your entry is confirmed. The Promoter is not liable for any problems with communications networks outside its reasonable control. You are responsible for your own costs associated with entering. - 19 Without limiting the previous paragraphs, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, damage to or delay in delivery of prize/s, or for any damage that occurs to displayed prize/s (where relevant), due to circumstances beyond the Promoter's reasonable control. Unless otherwise specified, prize/s will only be delivered to addresses in Australia.
