

NAB Goodies x McDonald's® Cashback Offer Terms and Conditions

Offer period commences on 7 May 2025 and ends on 30 June 2025, unless terminated earlier (Offer Period). The Offer Period consists of two qualifying periods:

- First qualifying period: 07/05/2025 – 04/06/2025
- Second qualifying period: 05/06/2025 – 30/06/2025

During the Offer Period, you may be entitled to two separate \$10 cashback rewards when you spend at McDonald's® (Offer) using your NAB personal debit card, NAB personal credit card, or NAB Now Pay Later (NNPL) digital card (Eligible NAB Card). For NAB personal credit card accounts, the Offer is only available to the primary cardholder. This Offer is not available to NAB business and NAB corporate card account holders.

To be eligible for the first \$10 cashback reward, you must spend \$25 or more at McDonald's during the first qualifying period (7 May 2025 and 4 June 2025) by completing the purchase with your Eligible NAB Card (First Reward).

To be eligible for the second \$10 cashback reward, you must spend \$25 or more at McDonald's during the second qualifying period (5 June 2025 and 30 June 2025) by completing the purchase with your Eligible NAB Card (Second Reward).

The maximum cashback amount that can be earned by the primary cardholder on an Eligible NAB Card over the Offer Period is \$20, capped at one \$10 cashback reward per qualifying period.

Cashback rewards are limited to the first 7,000 NAB customers who qualify per qualifying period.

You have been specifically selected for this Offer and it cannot be transferred, exchanged, or redeemed for cash or other credits. Participation in the Offer is only open to selected NAB customers who are Australian residents living in Australia, at least 18 years old, with an open and valid Eligible NAB Card and who have met the eligibility criteria for the Offer.

To be eligible for a cashback reward, transactions must be made within the specified Offer Period and settled within 5 days. Rewards apply to domestic purchases only at McDonald's.

If you become eligible for any cashback rewards under this Offer, we will credit them to you within 14 days after your qualifying transaction has been completed (although sometimes it may take longer, up to 60 days). Any cashback rewards will be credited as follows:

- If a NAB personal credit card was used, the cashback reward/s will be credited to your most used card and the cashback reward will appear as a separate line item on your statement as 'NAB MCDONALDS OFFER'
- If a NAB personal debit card was used, the cashback reward/s will be credited to your most used card that is linked to that NAB personal debit card and the cashback reward will appear as a separate line item on your statement as 'NAB MCDONALDS OFFER'
- If a NNPL digital card was used, we will credit your most used card. If this is your NNPL account, the credit transaction will appear with a transaction narrative that includes the words 'NAB MCDONALDS OFFER' and the cashback reward will be then swept to the transaction account linked to your NNPL account and appear on that transaction account statement as a separate line item with the words 'NAB NOW PAY LATER SWEEP'.

This Offer only applies to transactions made via the MyMacca's® app or in restaurant.

This Offer does not apply if the transaction is made using another third-party establishment or payment processor to which your Eligible NAB Card or linked account is connected. This includes (but is not limited to) PayPal, AfterPay, Stripe, Shopify.

This Offer does not apply to transactions made via third-party delivery services. This includes (but is not limited to) Uber Eats, Menulog, and DoorDash.

eftpos payments are not eligible for this Offer. eftpos payments are payments which are made by inserting your card at a Point of Sale (POS) and selecting 'CHQ' or 'SAV', or any payment which is routed by the merchant through eftpos (which may include without limitations payments made by tapping your card at POS). Whether a transaction is routed through eftpos is at the merchant's discretion and NAB has no control over the merchant's decision. You acknowledge and agree that NAB is not responsible for providing you with any advice on whether a purchase made is/will be routed to eftpos which may result in you not receiving a reward.

This Offer is subject to your Eligible NAB Card being open and valid, and any linked account being open and not in default, for the duration of the Offer Period. You will become ineligible for the Offer if you cancel, block or replace (including transfer of product, lost/stolen) your Eligible NAB Card at any time prior to the reward being credited to your card or the linked account. Acting reasonably, NAB has the right to withdraw or claim back any reward related to conduct it deems to have arisen out of fraud or willful misconduct.

NAB and McDonald's reserve the right to amend or withdraw this offer at any time. NAB will communicate any variations, terminations, or extensions of this Offer to you on nab.com.au/goodies or through other electronic communications such as email or the NAB app. Circumstances where prior notice may not be possible include where we are affected by events outside of NAB's control.
