

NAB Goodies Visa Boyz II Men Pre-Sale Ticket Offer

Terms and Conditions

1. These terms and conditions apply to the NAB Goodies Visa Boyz II Men Pre-Sale Ticket Offer (**Offer**). Information on how to access the pre-sale tickets form part of these Terms and Conditions. Purchase of pre-sale tickets subject to the Offer is deemed acceptance of these Terms and Conditions.
2. This Offer is provided by National Australia Bank Limited (ABN 12 004 044 937) (**NAB**) and fulfilled by Ticketmaster or Ticketek (**Ticket Partner**), depending on the date and venue selected.
3. To be eligible for the Offer (an **Eligible NAB Customer**), a customer must have access to NAB Goodies in the NAB app. Enrolment eligibility applies as per NAB Goodies “My Offers” Terms and Conditions.
4. Tickets subject to the Offer must be purchased using an open and valid NAB personal Visa debit card, NAB personal Visa credit card or NAB Now Pay Later digital card (each an **Eligible NAB Card**). NAB Business Visa debit cards and NAB Business Visa credit cards are not eligible cards.
5. The Offer is available from 13 July 2026 at 11:00am local time until 15 July 2026 at 11:00am local time, or until ticket allocation is exhausted, whichever occurs first (**Pre-Sale Period**). Local time means the time in the location of the customer’s selected event.
6. The Offer may be varied or withdrawn at any time. If the Offer is varied or withdrawn, NAB will communicate this by updating the Offer details on nab.com.au/presale
7. Under the Offer, Eligible NAB Customers can access pre-sale tickets for the events during the Pre-Sale Period. Pre-sale is not a preferential seating service and does not reduce the price of tickets to the event(s).
8. To purchase pre-sale tickets, during the Pre-Sale Period an Eligible NAB Customer must:
 - a) Follow the NAB Goodies pre-sale link available at nab.com.au/presale to navigate to the relevant Ticket Partner page;
 - b) Select their tickets; and
 - c) Pay with an Eligible NAB Card.
9. Pre-sale tickets are subject to availability and the pre-sale may be withdrawn or amended without notice.
10. The Offer is limited to a maximum of four pre-sale tickets per transaction.
11. Pre-sale tickets are sold and fulfilled by the Ticket Partner, not NAB or Visa. Ticket Partner terms and conditions apply. Tickets are subject to the rules, terms and conditions, prices and fees set up by each Ticket Partner. Tickets are subject to availability and supply may be limited. Not all seats may be offered; purchase limits and blackout dates may apply. Refunds, exchanges and re-sale may be
