3. Identify the transaction that you wish to obtain the customer's advice letter and move your mouse to the Actions column, which will provide options available to you, being **View**, **Correspondence**, **Repay** or **Details**. To access customer advices, click on the **Details** link.



4. The Details screen displays Transaction Details, Events and Additional Information. Click on the **Additional Information** link. This shows any Bank Attachments, Customer Attachments and also Fees and Charges details linked to the specific transaction.
